

"INVEST FOR A NEW ERA" CAMPAIGN TERMS AND CONDITIONS

DIF BROKER — EMPRESA DE INVESTIMENTO, SA ("DIF BROKER") develops this commercial Campaign named "Invest for a new era" ("Campaign"), which will be governed by the following terms and conditions (hereinafter "Terms and Conditions"):

1. CAMPAIGN DESCRIPTION:
